PARENTS/GUARDIAN AGREEMENT AND RELEASE

I/We the parent(s) and/or guardian(s) of the minor child _____, hereby give permission for said minor child to attend the Sailing Camp utilizing boats donated or borrowed from various owners for use in the program. I/We recognize and understand that the use of the facilities by the minor child may expose him or her to risk of injury.

I/We acknowledge that the minor child will be using the facility and the boats provided at his or her own risk. Furthermore, in consideration of Harbor Island Yacht Club (HIYC), Percy Priest Yacht Club (PPYC), Metropolitan Board of Parks and Recreation (Metro Parks), Nashville Sailing Foundation (NSF) and the various owners of the boats utilized in the program allowing the minor child to utilize the premises, facilities and equipment, I/We agree to release, discharge, hold forever harmless and indemnify HIYC, PPYC, Metro Parks, NSF and the various owners of the boats utilized in the program, their trustees, agents, directors, volunteers, officers, servants, and employees against loss from any and all claims, demands, rights, causes of action of any kind or nature that may hereinafter at any time be made or brought by the said minor, by anyone on behalf of said minor, by us, or by any other person having a legal interest herein arising from or by reason of any and all known or unknown, or seen or unforeseen bodily or personal injuries, damages to property and consequences thereof which may be sustained by said minor or by us in consequence of any accident or injuries in connection with Sailing Camp. Said indemnification shall include, but not be limited to court costs and attorneys fees. Furthermore, I/We agree to indemnify HIYC, PPYC, Metro Parks, NSF and the various owners of the boats utilized in the program from any loss or damage to the premises, facilities or equipment of HIYC, PPYC, Metro Parks and NSF to the extent that the same is not covered by insurance. If the minor child should suffer an injury or illness while at the facility, I/We authorize HIYC, PPYC, Metro Parks and NSF, their employees, members and volunteers to use their discretion to transport or to have the minor child transported to a medical facility and I/We take full responsibility for that action. I/We have read the foregoing release and understand that I/We are signing a release and bar to any claims as defined above resulting from the use of the facilities or equipment in connection Sailing Camp by the minor child.

Dear Parent and Junior Sailors,

It's time for sailing camp! We have a great group of enthusiastic and talented counselors who will be waiting for you at the lake. Following are some policies and helpful hints to keep everyone safe and happy at camp:

- Monday of each week is registration day. Try to arrive a little earlier, by 12:30, so that your head counselors can place you in a group. The counselors will also host a short parents' meeting after everyone is registered.
- All sessions are from 1-6 PM. No meals will be served but snacks and drinks will be provided. We will provide plenty of water.
- Please arrive at 1:00 sharp the remainder of each week. If the wind is good, we will immediately rig the boats and head out on the water. If you are late, it is possible that you will be sitting on the shore until someone can come and get you!
- Parents sign campers in and out each day; please do not drop your camper without making sure he or she is with a counselor. If you are going to be late or absent, call your counselor so he or she will know when to expect you.
- Parents, note your pick up time is during rush hour and plan accordingly. The counselors have a least an hour's worth of work after everyone goes home.
- We will send home a contact list of instructors' and supervisors' cell numbers as well as yacht club phone numbers on Monday.
- **TO BRING:** sunscreen, hat, sunglasses, water shoes- either crocs, flip flops, or old tennis shoes, a towel and a change of clothes. Make sure all items are marked with the camper's name. Sailors should arrive with swimsuits already on.
- **Every camper MUST have a comfortable, well fitting Type III P.F.D. (life jacket).** A "ski vest" type of life jacket is safer and more comfortable than an older type orange "horse-collar". Type III vests are available at Walmart and Target.
- Friday at 5:00 we will have an awards ceremony and pizza party. Parents and siblings are invited! Bring your camera!
- Do not hesitate to call an adult supervisor or your instructor with questions or concerns.
- The code to get into the gate at Harbor Island is #7890 (you must key "#" before the numbers!)
